Food Service Establishments, Food Stores, Bars

**New City Permits (Bryan and College Station)** – (Includes plan review, walk-through inspection, opening inspection, and compliance inspections for first year. Fees will be prorated by quarter)

low risk (no food prep): \$500.00

medium/high risk (food prep/service): \$700.00

**New Mobile Units or Push Carts** – (Includes plan review, walk-through inspection, opening inspection, and compliance inspections for first year. Fees will be prorated by quarter)
